Warning...fine print...

CLASS CHANGES / WITHDRAWALS: Dancers are permitted to change classes BEFORE Recital costumes are ordered in December. To avoid future charges, withdrawal from a class/studio must be RECEIVED in writing or email by a parent/guardian by the **15th the month before the drop will occur.** (Ex. Drop class in Nov...notice is due by Oct 15.)

COSTUME / RECITAL FEES: COSTUME fees for the June Recital, will be charged to your auto-pay on the date noted on your costume notices distributed in November and **must** be paid by mid-December or costume cannot be ordered. RECITAL fees are due in March before Spring Break.

PAYMENT POLICIES: Tuition for the 10 month Fall/Spring dance year is divided into 10 equal payments from Aug/Sept-June. Full tuition is due on the 1st of each month regardless of attendance &/or school holidays. Tuition payments do not vary due to holidays or the number of weeks in a month. All tuition & various fees must be paid via Auto-Draft using a Discover, Master, Visa credit/debit card or bank/savings account.

It is the responsibility of the parent to update the Studio for an expired/replaced card. A \$15 charge may be applied to the account for each unapproved transaction. If for any reason tuition is not received by the 3rd of the month, a \$15 charge will be applied to the account.

STUDENTS with UNPAID TUITION OR FEES or whatever reason, may not be permitted to participate in classes, Recital, or other special performances.

PLEASE NOTE: TUITION, COSTUMES, RECITAL/OTHER FEES ARE NON-REFUNDABLE OR NON-TRANSFERABLE BETWEEN DANCERS, REGARDLESS OF MISSED/DROPPED CLASSES OR EARLY WITHDRAWAL FROM CLASS OR THE STUDIO ENTIRELY.

INJURIES/WAIVER OF LIABILITY/AUTHORIZATION (more fine print!)

RELEASE OF LIABILITY: I understand there is a risk of personal injury with dance, tumbling and cheerleading classes and performances as with any sport. I represent that the above named student is in good health and physically capable of participation in registered classes, performances, including Recital. On behalf of myself,(the above named student, if different than the undersigned), I thereby waive and release any claim against Danzco. Dance Academy, Juanita Sanders, and their staff, contracted or employed, heirs, landlord and contractors arising out of personal injury occurring in connection with classes, performances, or Recitals.

MEDICAL EMERGENCIES: I, the parent/guardian accept responsibility for obtaining appropriate accident, health, and hospitalization insurance for the student in the event of personal injury. In the event of an injury or other medical emergency if I cannot be reached, I the parent/guardian of the dancer named above, authorize you or a representative of Danzco. Dance Academy to seek any reasonable medical assistance required in your judgment and I agree to be responsible for those medical expenses incurred on behalf of the dancer.

PROPER DANCEWEAR and shoes are required for classes. This enables the teacher to properly observe the students body movements for correct form and technique. Repeated failure to follow the dress code could result in student being asked to sit out or be removed from the class.

HAIR: Pulled away from the face and secured: ponytail, bun, bobby pins, clips, soft hair bands, *find something!!*

JEWELRY: None, nada, leave it with Mom, put it in your bag. You may wear small ear studs. No visible tattoos or body piercings.

BOY or BOOTY SHORTS: Must be worn w/tights or leggings to cover thigh.

CLASS DRESS CODES:

- **BALLET/TAP COMBO:** Black leotard, pink tights, pink ballet shoes (not slippers), black tap shoes. Skirts or black boy shorts are allowed for all other Ballet/Tap combo classes.
- **LYRICAL BALLET:** Any tight fitting dance/athletic wear. Any color Boy shorts are allowed & Foot Undeez or Pirouette shoes.
- **CLASSICAL POINTE:** Black leotard, pink tights. Skirts or black Boy shorts allowed. **Professionally fitted Pointe shoes**, and pink Ballet shoes.
- **BALLET BARRE/DEMI-POINTE:** Black leotard, pink tights. Skirts or black Boy shorts allowed. Pink Ballet shoes or Demi-Pointe shoes.
- **MODERN/CONTEMPORARY:** Any tight fitting dance/athletic wear. Foot Undeez Pirouette shoes, or barefoot.
- **MUSICAL THEATRE JAZZ:** Any tight fitting dance/athletic wear. Black Jazz shoes or Foot Undeez.
- **JAZZ:** Any tight fitting dance/athletic wear. Black Jazz shoes or Foot Undeez.
- **STOMPIN' TAP:** Any tight fitting dance/athletic wear. Black Tap shoes.
- **HIP HOP:** Any tight fitting dance/athletic wear. Black, glitter dance boots. Knee pads are always recommended.
- **BOYS, ALL CLASSES:** Any solid t-shirt, & athletic shorts/pants. All black dance shoes. (Ballet/Tap class: White T-shirt & black Jazz pants)

PARENT'S RESPONSIBILITIES: Be aware of financial & activity deadlines. Information is easily obtained onsite, website, social media and emails!! *ILUV emails!!* So that we can better serve you and your child, inform Danzco. of any billing, address, phone, or email changes as soon as possible to avoid problems.

CLASS ATTENDANCE & TARDINESS: As in any area of study, attendance is important. We want our dancers to have every opportunity to "shine" at Recital, so please help your dancer make it to class during the year, and especially after February. Attendance has a great effect on their performance during Recital.

BEFORE & AFTER CLASS: The well-being of our students and their families is of utmost concern to us. Danzco. cannot be responsible for providing before or after class care for dancers. If you are running a little late, and it happens to all of us...call the studio & we will try to lasso your young dancer until you arrive.

INJURIES: If a student has injured their selves during a normal supervised dance activity, Danzco. staff will address & apply first aid as needed to make the student comfortable. Depending on the severity, a parent will be notified before or at the end of class. Parents/guardians of minor students and adult students waive the right to any legal action for any injury sustained on Danzco. property resulting from normal supervised dance activity as well as any injury sustained on Danzco. property resulting during unsupervised periods before or after class times.

VALUABLES/CELL PHONES: *The best way not to lose anything valuable, is don't bring anything valuable.* We at Danzco. will do everything we can to find your lost item, & usually we do, however, Danzo. cannot be held responsible for loss of personal items. Cubbies are provided for dancers dance bags & shoes. Cell phones should be put away out of sight & turned off or at least put on silent/vibrate.

LOST & FOUND: Please mark all belongings, **especially dance shoes!!** Any items left in the studio will be placed in the LOST & FOUND container located by the Front Office.. PARENTS, WE ENCOURAGE YOU TO CHECK THE LOST & FOUND CONTAINER OFTEN FOR LOST ITEMS as the container is emptied @ the end of each month. If it's shoes youre looking for...dont forget about the Recycle Shoe Bin in the back by the restrooms!! *Lost? Recycled? Who cares, as long as you find the thing!!*

FOOD, DRINK, CANDY OR GUM (YIKES!! Gum? We detest GUM!!) All food, drink, etc... should remain in the Reception Area. And, please be thoughtful of others around you & help us take care of our studio...*CLEAN UP AFTER YOURSELF!!*

DRESSING ROOMS/RESTROOMS: Restrooms should not be used for changing clothes. We have provided Dressing Rooms for this purpose. Our restrooms need to stay available for students in class and the parent's waiting,

Co. D COMPETITIVE TEAMS: Eligibility for competition begins at age 6 -18. Auditions are held annually and usually in May. Invitations may be extended to the parents of a dancer that exhibits special talents during the year. For more information, parents may sign for an Audition Packet of Info, available in April, at the Front Office.

PRIVATE LESSONS: Private lessons are available for all dancers who have missed numerous classes and need to catch up for Recital. Danzco. also offers private lessons for pageant training/preparation, Solo, Drill & Drill Officer tryouts as well as Team competitors. Information on pricing and scheduling is available at the Front Office or your dance Instructor.

HOLIDAYS/WEATHER CLOSINGS: Danzco. is proud to serve students from neighboring school districts. Since our studio is located within Montgomery ISD, we follow their academic calendar closely regarding student/teacher holidays & inclement weather closings. Therefore, occasionally there are circumstances that force us to cancel a portion or an entire evening's classes. Danzco. holidays will be posted prior to the event on the front studio wall, bi-monthly newsletter, website & emails! Remember? *ILUV emails!!* Parents/students will be notified via social media, emails and our website as inclement weather closings arise.
